

**ORDINANCE NO. 2021-17**

**BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF FULTON, STATE OF ARKANSAS, AND ORDINANCE TO BE ENACTED:**

**AN ORDINANCE APPROPRIATING PUBLIC FUNDS FOR THE EXPENSES OF THE COUNTY FOR THE YEAR 2021.**

**WHEREAS ARK. STAT. ANN. (17-001 (b) REQUIRES THE QUORUM COURT OF FULTON COUNTY, ARKANSAS, TO APPROPRIATE PUBLIC FUNDS FOR THE EXPENSES OF THE COUNTY EACH YEAR BY ORDINANCE.**

**THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF FULTON COUNTY, ARKANSAS:**

**ARTICLE I. THAT THE PARTICULAR FUNDS, AS HEREINAFTER SET OUT ARE HEREBY APPROPRIATED TO BE APPLIED TO THE RESPECTIVE PURPOSES SET FORTH HEREIN:**
