**BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF FULTON, STATE OF ARKANSAS,
AN ORDINANCE TO BE ENACTED:**

**AN ORDINANCE APPROPRIATING PUBLIC FUNDS FOR THE EXPENSES OF THE COUNTY FOR THE
YEAR 2022.**

**WHEREAS ARK. STAT. ANN. (17-001 (b) REQUIRES THE QUORUM COURT OF FULTON COUNTY,
ARKANSAS, TO APPROPRIATE PUBLIC FUNDS FOR THE EXPENSES OF THE COUNTY EACH YEAR
BY ORDINANCE.**

THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF FULTON COUNTY, ARKANSAS:

**ARTICLE I. THAT THE PARTICULAR FUNDS, AS HEREINAFTER SET OUT ARE HEREBY
APPROPRIATED TO BE APPLIED TO THE RESPECTIVE PURPOSES SET FORTH HEREIN:**

ARTICLE II. THAT THERE IS HEREBY APPROPRIATED:

\$296,879 COUNTY ROAD BOGGY POINT ROAD

\$3,149 COUNTY ROAD BOGGY POINT ROAD

\$5,357 COUNTY GENERAL COUNTY BUILDINGS (SR CITIZEN AC) IMPROVE OTHER THAN BLDGS

\$164,525 COUNTY GENERAL GRANTS-IN-AID GENERAL SR CITIZENS GRANT (KITCHEN EQUIP/DELIVERY TRUCK)

\$86,271 ARPA REVENUE REPLACEMENT FUND AIR COOLED CONDENSING UNIT (HOSPITAL)

\$30,823 LAW ENFORCEMENT SALES TAX VEHICLES

\$11,016 COUNTY LIBRARY ARP FUND LIBRARY ARP FUND COMPUTERS ETC IMPROVE OTHER THAN BLDGS
