THE FULTON COUNTY QUORUM COURT MET IN SPECIAL SESSION AT 6 P.M. AT THE FULTON COUNTY FAIRGROUNDS CIVIC CENTER. THE MEETING OPENED WITH PLEDGE AND PRAYER.

ROLL CALL BY CLERK BISHOP WITH 7 JUSTICES PRESENT. JUSTICE MATTHEW AND JUSTICE ROGERS WERE ABSENT.

JUDGE STATED THE MEETING IS FOR AN AMENDMENT TO A RESOLUTION TO USE BANK OF SALEM INSTEAD OF BANCORP SOUTH. THE COUNTY WILL BE SAVING .30% INTEREST, THE TERMS ARE THE SAME, AND WE WILL BE KEEPING THE LOAN LOCAL.

CLERK BISHOP READ RESOLUTION 2023-02 A RESOLUTION AUTHORIZING THE ACQUISITION OF A ROAD GRADER. THIS RESOLUTION WILL GIVE THE COUNTY JUDGE THE AUTHORITY TO EXECUTE THE PURCHASE AGREEMENT AND LOAN TRANSACTION DOCUMENTS TO PURCHASE 3 MOTOR GRADERS FOR THE FULTON COUNTY ROAD DEPARTMENT THROUGH THE BANK OF SALEM. A MOTION WAS MADE BY DENNIS KINDER AND SECONDED BY CRIS NEWBERRY TO ADOPT RESOLUTION 2023-02. AFTER DISCUSSION, THE MOTION PASSED BY ROLL CALL 7 YEAS. (RESOLUTION 2023-02)

PUBLIC COMMENT WAS ASKING IF THE TRAINING OF THE EMPLOYEES WAS PART OF THE REASONS ROADS WERE NOT BEING GRADED. JUDGE CROW SAID HE HAS HAD SEVERAL CALLS SAYING THEY APPRECIATED THE ROADS GETTING SOME ATTENTION. HE STATED IT IS JUST GOING TO TAKE SOME TIME, AND THEY ARE DOWN ONE GRADER AT THIS TIME.

A REMINDER TO THE JUSTICES THE REGULAR FEBRUARY MEETING WILL BE HELD ON TUESDAY, FEBRUARY 21, 2023 DUE TO PRESIDENT'S DAY.
