A MOTION WAS MADE BY ALBERT ROORK AND SECONDED BY ROBERT ELLIOTT TO ACCEPT THE TREASURER'S REPORT. THE MOTION PASSED BY ROLL CALL VOTE 9 YEAS.

## **OLD BUSINESS**

JUDGE CROW GAVE AN UPDATE ON THE RADIO SYSTEM AND THE COURTHOUSE RENOVATIONS.

## **NEW BUSINESS**

JUDGE CROW STATED THE FEDERAL AUDIT FOR THE ARPA FUNDS HAD BEEN COMPLETED, AND THE AUDIT WAS GOOD. THE SECOND ROUND OF TRIBAL FUND MONEY IN THE AMOUNT OF \$50,000 HAS BEEN APPROVED.

DEBBIE MOORE WITH THE FULTON COUNTY LIBRARY BOARD GAVE AN UPDATE ON THE LIBRARIES. SHE REQUESTED A \$25,000 APPROPRIATION FOR ROOF REPAIR AT THE MAMMOTH SPRING LIBRARY, AND AN AWNING FOR THE SALEM LIBRARY. A MOTION WAS MADE BY JIMMY MARLER AND SECONDED BY ALBERT ROORK TO APPROPRIATE \$25,000 LIBRARY FUND BUILDING MATERIALS & SUPPLIES. THE MOTION PASSED BY ROLL CALL VOTE 9 YEAS.

JUDGE CROW REQUESTED AN APPROPRIATION FROM THE TOTALED DUMP TRUCK. A MOTION WAS MADE BY ALBERT ROORK AND SECONDED BY JIMMY MARLER TO APPROPRIATE \$115,000 COUNTY ROAD EQUIPMENT. THE MOTION PASSED BY ROLL CALL VOTE 9 YEAS.

A MOTION WAS MADE BY ROBERT ELLIOTT AND SECONDED BY CARRIE ANDREWS TO ACCEPT THE TOTAL ABOVE APPROPRIATIONS IN THE AMOUNT OF \$140,000. THE MOTION PASSED BY ROLL CALL VOTE 9 YEAS.

PUBLIC COMMENT JUSTICE KINDER AND JUSTICE MARLER ASKED TO TAKE THE VOTE ON THE MITIGATION PLAN. JUDGE CROW ASKED TO WAIT UNTIL OCTOBER ALONG WITH JUSTICE ANDREWS AND JUSTICE PHILLIPS STATING THEY WERE NOT READY TO VOTE. NO ACTION WAS TAKEN.

A MOTION WAS MADE BY CARRIE ANDREWS AND SECONDED BY GARY PHILLIPS TO ADJOURN AT 6:14 P.M. THE MOTION PASSED BY VOICE VOTE 9 YEAS.
