**BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FULTON, STATE OF ARKANSAS:  
AN APPROPRIATION ORDINANCE TO BE ENTITLED:**

**AN ORDINANCE AUTHORIZING LUMP SUM EXTRA COMPENSATION  
FOR FULTON COUNTY EMPLOYEES FOR 2023**

**WHEREAS**, Fulton County desires to positively recognize the hard work and efforts of its employees.

**WHEREAS**, each employee who has been employed with Fulton County since Jan 1<sup>st</sup>, 2023 will receive extra compensation payable with the first December 2023 payroll in the amount of \$350.00 for full time employees and \$100.00 for part time employees.

**NOW THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF FULTON, STATE OF ARKANSAS THAT:**

- Section 1: That Fulton County's payment to all current employees who were employed by Fulton County since January 1<sup>st</sup>, 2023, and who worked an average of twenty (20) hours per month in 2023 according to your payroll record as of December 15<sup>th</sup>, 2023, extra compensation , payable with the first payroll in December 2023 in the amount of \$350.00 for full time and \$100.00 for part time, is hereby authorized and approved by the Quorum Court
- Section 2: That this extra compensation payment shall only be paid one (1) time pursuant to this Ordinance, and does not constitute a continuing financial obligation to employees.
- Section 3: That this ordinance does not provide for any unlawful compensation of Justice of the Peace outside of their per diem fixed by ordinance pursuant to Arkansas Code annotated Section 14-14-1205.
- Section 4: That this ordinance excludes elected officials.
- Section 5: That ordinances or parts thereof in force at the time this ordinance shall take effect that are in conflict herewith are hereby repealed.
- Section 6: That nothing herein shall be deemed to affect any rights or obligations not expressly addressed herein.
- Section 7: That in the event that any portion of this ordinance is declared inoperative or invalid because of a statute of judicial decision, then only that portion expressly so declared inoperative or invalid shall be affected thereby and all other provision hereof shall remain in full force and effect.

Section 8: Emergency Clause: This ordinance being necessary for the immediate preservation of the public's peace, health and welfare, an emergency is hereby declared to exist and that this ordinance should be in full force and effect from and after its passage and approval.




