

ORDINANCE NO. 2023 - 21

**“AN ORDINANCE LEVYING REAL AND PERSONAL PROPERTY TAXES FOR THE COUNTY, MUNICIPAL, AND SCHOOL DISTRICTS AND THE IMPROVEMENT DISTRICT TAXES FOR THE YEAR 2023 COLLECTED IN 2024”**

WHEREAS, ARKANSAS CODE ANNOTATED 14-14-904, REQUIRES THE FULTON COUNTY QUORUM COURT, AT ITS REGULAR MEETING IN NOVEMBER OR DECEMBER OF EACH YEAR, SHALL LEVY THE COUNTY TAXES, MUNICIPAL TAXES, SCHOOL TAXES, AND IMPROVEMENT DISTRICT TAXES FOR THE CURRENT YEAR.


