A MOTION WAS MADE BY ROBERT ELLIOTT AND SECONDED BY CARRIE ANDREWS TO ACCEPT THE CLERK'S REPORT. THE MOTION PASSED BY ROLL CALL VOTE 9 YEAS.

A MOTION WAS MADE BY GARY PHILLIPS AND SECONDED BY DENNIS KINDER TO ACCEPT THE TREASURER'S REPORT. THE MOTION PASSED BY ROLL CALL VOTE 9 YEAS.

OLD BUSINESS

JUDGE CROW GAVE UPDATES ON COURTHOUSE RENOVATIONS, RADIO TOWER, AND ROAD DEPARTMENT FUEL SYSTEM.

ASSESSOR LONG GAVE UPDATE ON THE GIS PROJECT. TWO COMPANIES HAVE BID ON THE PROJECT. ONE COMPANY SCORED LOW AND ONE SCORED ALMOST PERFECT. THE STATE THOUGHT THE BID WOULD BE AROUND \$250,000, BUT THE BID WAS \$747,000. STATE ASKED IF THEY COULD LOWER THE BID WITHOUT BIDDING, AND THEY DID LOWER IT TO \$428,000. FULTON COUNTY IS THE ONLY COUNTY IN THE STATE NOT MAPPED. OUR 40% WOULD BE \$171,000 FOR 2024 AND 2025. THE BIDDING HAS BEEN SUSPENDED ON HOLD DUE TO THE COST. ASSESSOR LONG STATED WE HAVE A COUPLE OF OPTIONS WHICH ARE CONTINUING WITH REBIDDING WITH THE STATE GRANT, OR WE DO THE MAPPING OURSELVES. IF THE COUNTY MAPS, SHE WOULD NEED TWO MORE FULL-TIME EMPLOYEES GOING FORWARD. SHE HAS SUBMITTED TWO BUDGETS, ONE WITH EACH OPTION. SHE STATED THERE IS AN AGENCY WILLING TO HELP, BUT SHE DOESN'T KNOW HOW MUCH.
